


- 4. SEE SD 208.02 FOR ADA ACCESSIBLE SPACE REQUIREMENTS.
- 5. PARKING CONFIGURATIONS IN THE FORM BASED CODE ZONING AREA DIFFER FROM THIS DETAIL AND SHALL BE APPLIED SEPARATELY.
- 6. COMPACT CAR PARKING SPACES MAY BE USED FOR A PORTION OF THE REGULAR NON-ADA PARKING BASED ON ZONING.COMPACT SPACES SHOULD BE INSTALLED 8 FEET WIDE BY 16 FEET LONG FOR 90-DEGREE PARKING LAYOUT.



- STANDARD PARKING SPACES AND ADA PARKING SPACES SHALL BE PROVIDED IN ACCORDANCE WITH ADA STANDARDS FOR ACCESSIBLE DESIGN § 208.
- 2. ALL PAINTED PARKING STALL LINES FOR ADA PARKING SPACES SHALL BE BLUE 4" WIDE LINES.
 - CROSSHATCHING IN THE ACCESS AISLE SHALL BE 4" WIDE SOLID BLUE LINES TO EMPHASIZE THAT PARKING IS PROHIBITED IN CROSS HATCHED AREAS.
 - THE ACCESS AISLE MAY BE SHARED BY 2 ADA SPACES. ONE OF EVERY 6 ADA SPACES AND NO LESS THAN ONE SHALL BE VAN ACCESSIBLE.
 - A SEPARATE SIGN SHALL BE PROVIDED FOR EACH ADA PARKING SPACE.
 - MOUNTING HEIGHT FOR SIGN MAY BE REDUCED TO 5' ABOVE GROUND LEVEL IF IT IS LOCATED IN A
 - NON-PEDESTRIAN AREA, SUCH AS ON A BUILDING OR A LANDSCAPED AREA.
 - VAN ACCESSIBLE SIGN, WHEN USED, SHALL BE MOUNTED BELOW ADA PARKING SIGN.
- 9. ADA PARKING MUST BE PLACED IN THE NEAREST ACCESSIBLE PATHWAY TO ENTRANCE.
