

2024 Stormwater Fee Assistance Application United Way of Greater Chattanooga

Deadline to submit this application: April 5, 2025

The United Way Stormwater Fee Assistance program provides additional assistance to those who are approved for Tax Relief or Tax Freeze by paying the City of Chattanooga stormwater fee for your primary residence.

After your Tax Relief or Tax Freeze application is approved, United Way will send a payment, on your behalf, to the City of Chattanooga. The payment will be equal to the 2024 stormwater fee for 1 ERU (Equivalent Residential Unit), no greater than \$183.54. Payments will not include fees, interest or penalties from prior years. Properties with no stormwater fee are not eligible for payment though this program.

This program is open to all Tax Relief and Tax Freeze applicants, so let's get started!
