Two Sumitomo Gearboxes  
Supplier: Brozelco, Inc.

EXPLANATION: Gearboxes on the fine screens in the Wastewater Influent Pump Station have deteriorated under the harsh operating conditions. Two replacement gearboxes were ordered in April as an open market bid, but will not arrive until July. Currently, the south fine screen gearbox is inoperable and the north fine screen gearbox is in a similar condition. Should the north fine screen gearbox fail, the Influent Pump Station will be offline resulting in a more than 50% reduction of treatment capacity. This could lead to major east and west bank overflows into the Tennessee River during wet weather. The Wastewater Plant Maintenance team researched further and determined that non-painted gearboxes are available within four days. The previously ordered gearboxes will be kept in stock as critical spares. In the future, two gearboxes will be maintained in stock to prevent future emergency purchase conditions.
