A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A FIRST AGREEMENT TO EXERCISE OPTION TO RENEW WITH HELEN ROSS MCNABB CENTER, IN SUBSTANTIALLY THE FORM ATTACHED, FOR ONE HUNDRED TWENTY (120) SQ. FT. OF OFFICE SPACE IN A PORTION OF THE FAMILY JUSTICE CENTER LOCATED AT 5705 UPTAIN ROAD, IDENTIFIED AS TAX MAP NO. 157M-A-012, FOR AN ADDITIONAL TERM OF TWO (2) YEARS, IN THE AMOUNT OF TWO THOUSAND SIX HUNDRED FORTY DOLLARS (\$2,640.00).

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, that it is hereby authorizing the Mayor to enter into a First Agreement to Exercise Option to Renew with Helen Ross McNabb Center, in substantially the form attached, for 120 sq. ft. of office space in a portion of the Family Justice Center located at 5705 Uptain Road, identified as Tax Map No. 157M-A-012, for an additional term of two (2) years, in the amount of \$2,640.00.
