

RESOLUTION NO. 30428

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A FIRST AGREEMENT TO EXERCISE OPTION TO RENEW WITH PARTNERSHIP FOR FAMILIES, CHILDREN, AND ADULTS, INC., IN SUBSTANTIALLY THE FORM ATTACHED, FOR ONE HUNDRED SEVEN (107) SQ. FT. OF OFFICE SPACE IN A PORTION OF THE FAMILY JUSTICE CENTER LOCATED AT 5705 UPTAIN ROAD, IDENTIFIED AS TAX MAP NO. 157M-A-012, FOR AN ADDITIONAL TERM OF TWO (2) YEARS, IN THE AMOUNT OF TWO THOUSAND THREE HUNDRED FIFTY-FOUR DOLLARS (\$2,354.00).

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, that it is hereby authorizing the Mayor to enter into a First Agreement to Exercise Option to Renew with Partnership for Families, Children, and Adults, Inc., in substantially the form attached, for 107 sq. ft. of office space in a portion of the Family Justice Center located at 5705 Uptain Road, identified as Tax Map No. 157M-A-012, for an additional term of two (2) years, in the amount of \$2,354.00.
