RELEASE AND TERMINATION OF REVERSIONARY RIGHTS

WHEREAS, pursuant to that certain Quitclaim Deed dated October 4, 1996 and recorded in Book 4757, Page 716 in the Register's Office of Hamilton County, Tennessee ("Deed"), the City of Chattanooga, Tennessee, a municipal corporation of the State of Tennessee ("City"), conveyed certain property to Hamilton County, Tennessee, a political subdivision of the State of Tennessee ("County"), as described in the Deed, and said property is also described on <u>Exhibit A</u> attached hereto ("Property").

WHEREAS, pursuant to the Deed, City reserved unto itself certain reversionary rights with respect to the Property, such being that the Property will revert to City if County, at any time subsequent to the execution of the Deed, (i) ceases to provide health services to the general population of the County or (ii) sells the Property (collectively, "Reversionary Rights").

NOW, THEREFORE, for and in consideration of the sum of Ten and 00/100 Dollars (\$10.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, (i) City hereby waives all such Reversionary Rights; and City hereby forever releases all such Reversionary Rights; and (ii) City hereby acknowledges and agrees that the Reversionary Rights are hereby terminated and of no further force or effect.
