Janette Sterzik [View <u>here</u>] – She is the President of the Water Haven Homeowners
 Association at Water Haven Apartments. She requested a deferral of the vote due to her
 neighborhood becoming aware of the proposal only a few days ago.

<u>Rebuttal</u> [view <u>here</u>]: Mr. Price addressed the request for Heavy Industrial zoning, the conditions already in place, and the expansion on property away from the main road.

A discussion among the Council ensued [view here]. Councilman Clark noted that Water Haven was not located in District 5. He named the District 5 neighborhoods affected by this rezoning and confirmed their engagement during the rezoning process.

Councilman Clark moved to approve. Councilman Elliott seconded. Councilwoman Berz asked to hear the conditions on the rezoning, to which Ms. Rennich responded. Vice Chair Noel addressed Opposition's and supported deferring this item. **The motion carried, with Vice Chair Noel voting "No."**
