ORDINANCE NO. 14280

AN ORDINANCE TO AMEND THE OPERATIONS BUDGET ORDINANCE NO. 14239, KNOWN AS "THE FISCAL YEAR 2025-2026 OPERATIONS BUDGET," TO AMEND SECTION 5 TO PROVIDE FOR REALLOCATION OF APPROPRIATIONS TO THE DEPARTMENT OF EQUITY AND COMMUNITY ENGAGEMENT IN COMPLIANCE WITH THE DISMANTLING DEI ACT ENACTED IN MAY 2025 AS TENNESSEE STATE LAW, WHICH HAS RESULTED IN ADMINISTRATIVE ACTIONS WITH THE DISSOLUTION OF THAT DEPARTMENT; TO INCLUDE THE RESTRUCTURING OF GOVERNMENT FUNCTIONS AND CONSOLIDATION OF CERTAIN DEPARTMENTS; TO REALLOCATE APPROPRIATIONS BETWEEN CERTAIN DEPARTMENTS; AND TO AMEND SECTION 7(E) DUE TO ADMINISTRATIVE CHANGES DURING FISCAL YEAR 2025-2026 TO REALLOCATE APPROPRIATIONS FOR CERTAIN NEW OR CHANGED POSITIONS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, that Ordinance No. 14239 be amended as follows:

WHEREAS, the City of Chattanooga, Tennessee, is submitting an Ordinance repealing Sections 2-711 through Sections 2-719 within Ordinance No. 13909, which will dissolve the Department of Equity and Community Engagement;

WHEREAS, the Tennessee General Assembly has passed new legislation banning Diversity, Equity, and Inclusion (DEI) programs and policies in Tennessee, House Bill 0923/Senate Bill SB1084 (Public Acts 2025 P.C. 458) and House Bill 622/Senate Bill SB1083 (Public Acts 2025 P.C. 494)

NOW, THEREFORE, BE IT ORDAINED by the City Council of Chattanooga, Tennessee, be amended as follows:

SECTION 1. That section 5 of Ordinance 14239 related to General Fund Appropriations for Fiscal Year 2025-2026 be amended as follows:
