PUBLIC NOTICE

Take notice, pursuant to Chapter 442, Tennessee Public Acts of 1974, the Sunshine Law, and amendments thereto: The City of Chattanooga's Operations and Capital budgets for Fiscal Year 2026-2027, as more fully described below, will convene a public hearing on Tuesday, June 2, 2026, during the 3:30 p.m. business meeting to receive comments from residents. These ordinances will both come before the City Council of the City of Chattanooga for first reading on Tuesday, June 16, 2026, during the 3:30 p.m. business meeting, and if passed, for second and final reading on Tuesday, June 23, 2026, during the 3:30 p.m. business meeting. (All times listed herein are local times.)

Operations Budget:

AN ORDINANCE, HEREINAFTER ALSO KNOWN AS "THE FISCAL YEAR 2026-2027 OPERATIONS BUDGET", PROVIDING REVENUE FOR THE FISCAL YEAR BEGINNING JULY 1, 2026, AND ENDING JUNE 30, 2027; APPROPRIATING SAME TO THE PAYMENT OF EXPENSES OF THE MUNICIPAL GOVERNMENT; FIXING THE RATE OF TAXATION ON ALL TAXABLE PROPERTY IN THE CITY, AND THE TIME TAXES AND PRIVILEGES ARE DUE, HOW THEY SHALL BE PAID, WHEN THEY SHALL BECOME DELINQUENT; PROVIDING FOR INTEREST AND PENALTY ON DELINQUENT TAXES AND PRIVILEGES; AMENDING CHATTANOOGA CITY CODE, PART II, CHAPTER 2, SECTION 2-267, RELATIVE TO PAID LEAVE FOR ACTIVE-DUTY TRAINING AND TO AMEND CHATTANOOGA CITY CODE, PART II, CHAPTER 31, SECTIONS 31-36, 31-37, 31-41, AND 31-43, SECTIONS 31-322 AND 31-354

Capital Budget:

AN ORDINANCE APPROPRIATING, AUTHORIZING OR ALLOCATING FUNDS TO THE CAPITAL IMPROVEMENTS BUDGET FOR THE FISCAL YEAR 2026-2027.

The public hearing will take place in the Assembly Room of the John P. Franklin, Sr. City Council Building, located at 1000 Lindsay Street, Chattanooga, TN 37402. The business meeting and public hearing are open and accessible to the public.
