This work will be built upon evidence-based programming related to building the capacity of our communities to be resilient and to address the complex needs of modern families. As a part of the Office of Early Learning in the Department of Youth and Family Development, this position will align with existing efforts and will be responsible to the Office of Early Learning's goals of developing the early education infrastructure and building community support for early education. Works under the general direction of the Director of the Office of Early Learning.

Use data-driven decision making, and report on outputs and outcomes at regular intervals.

Represent the City of Chattanooga's early education system in local, state, and national forums.

Procure, manage, and/or supervise contractors, consultants, and/or staff as needed.

Must meet regular attendance requirements.

Must be able to maintain good interpersonal relationships with staff, co-workers, managers and citizens.

Must accomplish the essential functions of the job, with or without reasonable accommodations, in a timely manner.
