COUNCIL MEETING MINUTES

September 9, 2025 3:30 PM

CALL TO ORDER

Council Chairwoman Jenny Hill called the business meeting to order at 3:30 p.m. A quorum was present that also included Vice Chair Marvene Noel, and Councilmembers Chip Henderson, Jeff Davis, Dennis Clark, Jenni Berz, Raquetta Dotley, and Ron Elliott. Councilman Cody Harvey was not present.

PLEDGE OF ALLEGIANCE

Councilman Clark led the Assembly in the Pledge of Allegiance and gave an invocation.

APPROVAL OF LAST MINUTES

On motion of Councilwoman Dotley and seconded by Councilman Elliott, the minutes of the last meeting (August 26, 2025) were approved as published.

OTHER BUSINESS:

Chairwoman Hill extended special congratulations to Councilman Harvey, who was not present, on the birth of his new daughter and requested a round of applause in honor of Baby Harvey.

DISCUSSION AGENDA

ORDINANCES - FIRST READING:

Agenda Item VIII(a) - Planning - Case No. 2025-0123

Chairwoman Hill requested a motion from the Council to defer this item, given Councilman Harvey's absence and his request for a two-week deferral. Upon no further comments or questions, the issue was closed.

RESOLUTIONS:

Agenda Item IX(c) – Council Office (Support of workers at Volkswagen)

The resolution authors have requested additional time to revisit the language, specifically requesting a few more weeks. Therefore, Councilman Elliott advised that he would request a 3-week deferral until September 30th. Upon no further questions or comments, the issue was closed.

Agenda Item IX(d) – Council Office (Waiving Residential Modification Permit fees)

Chairwoman Hill requested a one-week deferral until September 16, in order to change some of the language. Councilman Elliott requested clarification on the fee protection for this resolution, to which Attorney Noblett explained the permitting modification fees. Upon no further questions or comments, the issue was closed.

PURCHASING QUESTIONS:

Councilman Clark inquired about Technology Services item PA100010, specifically regarding the increase to Software services. Mr. Neeld responded to the councilman questions. Upon no further questions or comments, the issue was closed.

Chairwoman Hill requested an explanation of the Technology Services item REQ169753 and what an Integrated Ballistic Identification System entails. Chief Chambers provided a detailed explanation. Upon no further questions or comments, the issue was closed.

Councilman Elliott inquired about detailed purchase item costs, cost centers, and the lifecycle of funds, to which Mr. Roig responded. Councilman Clark asked about publicly accessible expenditure explanations to inform the public. Mr. Roig explained about the budget being public to enhance transparency for constituents. Upon no further questions or comments, the issue was closed.

SPECIAL PRESENTATION

Chairwoman Hill invited Mr. Roig to present information regarding new budget allocations necessitated by recent state law amendments. Mr. Roig delivered a presentation detailing the community development modifications stemming from the recently-enacted legislation on the dissolution of Diversity, Equity, and Inclusion (DEI) departments.

- Councilman Elliott expressed his disappointment in the dismantling DEI, noting the impact on the Latino population.
- Councilwoman Dotley expressed her disappointment and gave her criticisms of the state legislation dismantling DEI.
- Chairwoman Hill wrapped up the discussion by conveying her agreement with the Council's disappointment. She expressed appreciation to the Mayor and Administration for supporting DEI and implementing the changes to ensure compliance.

Upon no further comments or questions, the issue was closed.
