September 16, 2025 3:30 PM

CALL TO ORDER

Council Chairwoman Jenny Hill called the business meeting to order at 3:30 p.m. A quorum was present that also included Vice Chair Marvene Noel, and Councilpersons Chip Henderson, Jeff Davis, Dennis Clark, Jenni Berz, Raquetta Dotley, and Ron Elliott. PLEDGE OF ALLEGIANCE

Councilwoman Berz led the Assembly in the Pledge of Allegiance.

APPROVAL OF LAST MINUTES

On motion of Vice Chair Noel and seconded by Councilwoman Dotley, the minutes of the last meeting (September 9, 2025) were approved as published.

SPECIAL PRESENTATION

<u>Public Hearing on Budget Ordinance</u> re: Community Development/Dismantling DEI Departments Act

A Public Hearing ensued on the following:

AN ORDINANCE TO AMEND THE OPERATIONS BUDGET ORDINANCE NO. 14239, KNOWN AS "THE FISCAL YEAR 2025-2026 OPERATIONSBUDGET," TO AMEND SECTION 5 TO PROVIDE FOR REALLOCATION OF APPROPRIATIONS TO THE DEPARTMENT OF EQUITY AND COMMUNITY ENGAGEMENT IN COMPLIANCE WITH THE DISMANTLING DEI ACT ENACTED IN MAY 2025 AS TENNESSEE STATE LAW. WHICH HAS RESULTED IN ADMINISTRATIVE ACTIONS WITH THE DISSOLUTION OF DEPARTMENT: TO INCLUDE THE RESTRUCTURING GOVERNMENT **FUNCTIONS** AND CONSOLIDATION OF CERTAIN **DEPARTMENTS: TO REALLOCATE APPROPRIATIONS BETWEEN CERTAIN** DEPARTMENTS; AND TO AMEND SECTION 7(E) DUE TO ADMINISTRATIVE DURING **FISCAL YEAR 2025-2026** CHANGES TO REALLOCATE APPROPRIATIONS FOR CERTAIN NEW OR CHANGED POSITIONS.

Chairwoman Hill yielded the meeting to Budget & Finance Committee Chair, Councilwoman Dotley, for a hearing on the ordinance. Councilwoman Dotley called the hearing to order at 3:31 p.m. and inquired if anyone wished to address the Council. She asked Attorney Noblett to read the rules of procedure. Councilwoman Dotley confirmed there were no speakers. She closed the public hearing at 3:33 p.m. and returned control of the meeting to Chairwoman Hill.

DISCUSSION AGENDA

ORDINANCES - FIRST READING:

Agenda Item VIII(b) - Mayor's Office (Ordinance to amend Operations Budget)

Councilman Henderson inquired about the Department of Equity and Community Engagement Chief Officer position following its elimination, specifically requesting details regarding the allocation of its associated funding. Ms. Green indicated she would provide further information on this matter at a later time. Additionally, Councilman Henderson raised questions regarding discrepancies within the budget book, to which Mr. Porter explained the budget book process and the schedule for updates. Councilman Elliott then inquired about potential job losses resulting from the department's dissolution, and Ms. Green confirmed that no employees would be terminated as a result. Upon no further questions or comments, the issue was closed.

Councilwoman Berz informed the Council that she would be making a motion to approve the alternate version of this resolution when it came up for a vote. Upon no further questions or comments, the issue was closed.

Councilwoman Dotley expressed excitement about this development and inquired about a presentation regarding the TIF. Councilman Elliott confirmed that there would be a full presentation on the TIFs. Upon no further questions or comments, the issue was closed.

AFFORDABLE HOUSING COMMITTEE

Housing PILOT for 702 Manufactures Road By: Hanneke Van Deursen

Councilwoman Dotley turned the floor over to Ms. Van Deursen, who presented an overview of the Housing PILOT for 702 Manufacturers Road. Mr. Reese also presented, which may be viewed here and touched on the following:

Afterwards, the floor was opened to questions and comments from the Council, which may be viewed here and touched on the following:

 Councilman Henderson inquired about the rezoning process and public river access, expressing concerns about potential access limitations.

- Chairwoman Hill expressed her gratitude to Mr. Reese and the development company for their willingness to implement the PILOT program, noting that they were able to identify financial solutions that are satisfactory to all parties involved.
- Councilman Harvey inquired about the application procedures and eligibility criteria for the
 affordable housing units, expressing gratitude to Mr. Reese for his development within our
 city.
- Committee Chairwoman Dotley inquired about surrounding properties with fuel tanks, specifically if the tanks were full and if they posed a threat to the development.
- Councilman Clark stated he is not a strong supporter of affordable housing projects but was pleased with this development and thanked Ms. Van Deursen for her help.

Upon no comments or questions, the issue was closed.

With permission from Chairwoman Hill, Councilwoman Dotley adjourned the Affordable Housing Committee at 4:10 p.m. and recessed the business meeting until 4:55 p.m.
