### CLASSIFICATION SUMMARY:

The Software Engineer I is responsible for assisting in developing products that support the City of Chattanooga. As a Software Engineer I, you will be part of a dynamic team with engineers of all experience levels who help each other build and grow technical and leadership skills while creating, deploying, and supporting production applications. In addition, Software Engineers may be involved in product configuration, security, resilience, performance tuning and production monitoring.

**SERIES LEVEL:** The Software Engineer I is the first level of a four-level Software Engineer series.

**KNOWLEDGE AND SKILLS:**

(AWS/GCP); server side technology such as NodeJS/Express; object-oriented programming language; source code version control. (Bitbucket); relational and non-relational database technology. (MSSql/MongoDB); linux virtual machines in a server environment; ticket management systems like JIRA.

Skills include the following: ability to read and apply technical documentation where required. Applicants should know at least one programming language well, preferably Javascript/NodeJS. Ability to obtain and maintain CJIS certification. Ability to pass a coding challenge.
